Eileen Nelson asked if a location for the cell tower had been determined. Farber responded that it would be located at the village sewer site. It would take approximately one year to build. She also said she received a notice regarding the drain commission and was wondering if she could pay one lump sum instead of the assessment being stretched out over 5 to 7 years. Farber suggested she speak to the Oceana County Drain Commissioner, Michelle Martin.
