**Police & Zoning Reports:** Chief Gibbs gave his report. Total 79 calls including 4 accidents, 2 juvenile arrests, 20 warrant/criminal arrests, 8 traffic citations, 2 site plan reviews, 1 construction permit, 2 lot splits. 6 Ordinance violations (2 animal, 1 property line dispute, 2 White River water shed and 1 DEW violations.

### **PRESIDENT/DPW Report:**

The Variable Frequency Drive has been installed in Pump #3.

Bill Thorne stated that he had gotten an estimate from Dixon for cleaning and inspection of water tower. The last inspection was done 9 years ago. He said that April was the tentative date. If would take 4 days to complete the process. He said the estimate to clean the outside of the tower would be around \$4,000.00 President Farber said that he would like to get in touch with some local fire departments to see if they wanted to clean the tower in a training exercise.

President Farber mentioned that there is \$6,187 available to use from the Fremont Area Foundation.
