**Police & Zoning Reports:** Chief FitzGerald reported that there were 23 calls for service; 3 arrests; 4 traffic citations and 1 zoning permit. He stated that Crash Reporting is now loaded on the police computers. All officers are trained on the E-Crash reporting program and the police department is now compliant with the State of Michigan reporting requirements. Chief FitzGerald spoke on some ordinance issues we are having. He said some of the hot spots are on Munn Street, Cook Street and he is working on some other streets as well. He has been called to the school a few times this week. Homecoming is this week and they will provide coverage for that.

**PRESIDENT/DPW Report**: President Farber reported that Main Street has been repaved and striped. He mentioned that Bill Thorne was working with the DEQ to see if it is OK to proceed with the cleaning of the ponds at the sewer site. President Farber mentioned that a Special Council meeting will be scheduled in the next 10 days on the Medical Marihuana Facilities Ordinance and that our attorney would be present. He mentioned that the Kubota was ordered and should be here sometime in October. He said that he would be reaching out to Beaver Tree service to remove some dead branches from the tree in Webster Park near the Veterans Memorial.

President Farber explained that the water/sewer invoice could not be put on the property taxes because the council failed to approve the ordinance at the last meeting. Mrs. Nelson inquired about the lot next to her house that was owned by the Catholic Church if they were exempt from the ordinance. The grass is very tall and has a lot of critters living in it.
