Public Comment:

Bill Rumsey inquired about the status of the Medical Marihuana Facilities Ordinance. President Farber explained that a draft copy had been passed out to the council members. David Huntley spoke about Armistice Day and that he wishes there was more public participation in ringing of the bell at the 11th hour to honor all veterans. He asked if the council could bring more attention to it next year. Eileen Nelson had some questions about the Medical Marihuana Facilities and who would be policing the building and streets. President Farber said that the individual group running the facility would be in charge of checking ID's etc., and the Hesperia Police Department would take care of any traffic on public streets. President Farber explained that Recreational Marihuana is different than Medical Marihuana. We would have to opt out of Recreational Marihuana being allowed in village. McDonald took a moment to thank all veterans for their service.
