Announcements/Correspondence: Pro-Tem McDonald mentioned that during last month's meeting when the committees were appointed, the Grants, Fundraising and Chamber Interact was inadvertently omitted and Sara Walker and Jackie Slocum will be on this committee with Jackie Slocum as the chairperson. McDonald read a letter from Sara Kraley from the Hesperia Beautification Committee thanking the DPW for helping hang the flowers baskets and placing the flower pots on Main Street. Their mission is to serve the community and promote civic beauty, community pride and environmental responsibility. Slocum said that she was contacted regarding chalk drawings on the sidewalks. McDonald wanted to have discussion with Zoning Administrator prior to making decision. Slocum and Walker agreed.

Committee Reports:

Ambulance:

Dams, Parks, Civic & Recreation: Chairperson Walker reported that the dam had two major events this spring and met with Mike Rosema regarding reinforcing the walkways with concrete. The recommendation is to accept his proposal for up to \$7,000. She reported that Scott Rumsey would be putting in the removable docks to the second island. Also reported that the water fountains are off in the parks due to COVID-19.

Technology: Chairperson Slocum reported they met on May 20, 2020 regarding updating the computer equipment in the village office. Recommendation is to accept the quote from IT Right in the amount of \$5,740.00.

Personnel: Chairperson McDonald reported that a meeting was held on June 4, 2020 regarding a personnel review for DPW employee Emmaline Woodward. The recommendation is to leave her as a part time employee and leave her wage at \$14.00.

Streets and Sidewalks:

Water & Sewer:

Finance, Budget & Insurance: Chairperson McDonald reported that Finance Committee met on May 20, 2020 and May 28, 2020 and the recommendations will be given under new business.

Ordinance: Chairperson McDonald reported that the Ordinance committee met on June 3, 2020 regarding the ordinances pertaining to chickens, junk vehicles and mowing of grass. No recommendation at this time.

Grants, Fund Raising, Chamber-Interact:

Buildings and Grounds: Chairperson Smith reported that a meeting was held on June 5, 2020 regarding reconfiguring the front office due to COVID-19. Further research is needed. No recommendation at this time. He also mentioned that there are some doors on the DPW garage and building connected to the police department that will need repair in the near future.

Police and Zoning: Chief Herremans reported that Officer Andrew Polasek has filled the full time position and Officer Fred Hull moved into the part time position after accepting another full time position elsewhere. During the COVID-19 pandemic, the Newaygo and Oceana County Emergency Preparedness coordinators have been valuable in keeping the department supplied with masks and gloves. Three zoning permits were issued in May. He believes when the State of Michigan enters the next phase of re-opening up, he will be able to start enforcing the junk and disabled vehicles ordinance and the mowing of grass.
