Herin received a call from Scott Rumsey regarding the NCATS Fiber Project. He explained that the only money that the village would be responsible for would be \$1,000 for the feasibility study. All other funds would be paid out by another organization.

Committee Reports: Ambulance: Buildings and Grounds: **Dams, Parks, Civic & Recreation:** Slocum said that they came up with a permit for special events and revised the Peddler Permit. They propose a fee of \$50.00 for the first day and \$20.00 for each consecutive day or an annual fee of \$175.00 for Special Events. For the Peddler Permit, they would like to charge \$50.00 for the first day and \$20.00 for each consecutive day.

Personnel: Chairperson McDonald reported that they had an interview with Mike Stanaway on August 25, 2020. The committee's recommendation is to hire him as D.P.W. Director. **Streets and Sidewalks:**

Technology: The committee met via Zoom with Julie Burrell regarding the NCATS Fiber Project. There seems to be a miscommunication in the information they received than what Herin received from Scott Rumsey. Slocum will go back to them and get additional information. **Water & Sewer:**

Police and Zoning: Chief Herremans reported that there were 4 zoning requests, 17 ordinance investigation/warnings, 69 complaints, 110 traffic contacts, 3 traffic accidents and 7 arrests. The Watch Guard camera system has been installed in the patrol cars and is working with technical support to get them operational. He reported that the Village of Hesperia has been accepted into the West Michigan Training Consortium and will look into getting training for his officers. He spoke with the Superintendent of Hesperia Schools regarding assistance with the pick up/drop off procedure at the elementary school. They had a couple of meeting and believe there is a plan going forward.

DPW Report: The new D.PW. Director, Mike Stanaway gave a brief report. He thanked President Farber for putting everything in place prior to his arrival as it made his job much easier. Repairs are under way. The department is working on replacing water meters. They have reached out to the homes that have zero usage by trying to contact residents and putting notes on the doors. Zero usage cannot be tolerated as it directly effects the village's income. He is very pleased with the crew that was assembled. He said that he could not have hand picked a better one. They all work well together. The department will start to prepare for winter. There was vandalism in Vida Weaver Park with the portable toilet and in Webster Park where a park bench was broken.
