The drive train and transition issues have been repaired on the older Kubota. He reported that there was only one freeze up this winter and customer forgot to let water drip over the weekend. The sewer lift station pump has been repaired and returned from Kennedy. There were 23 Miss Digs and 18 of them were for the monitor wells at the Sunoco station. The public restrooms in the parks are scheduled to be repaired, cleaned and painted. The overhead door for 171 N. Elm has been back ordered until March 17, 2021.
