Announcements/Correspondence: McDonald said she was contacted by B.H.S. Insurance about wanting to provide a quote to the village. She will get a committee meeting set up. Slocum said she was contacted by a parent regarding an incident at the Mobil station. Slocum said that she invited the parent to the meeting, and since she did not attend, brought the matter to the council's attention. The police chief spoke regarding the matter and said the Mobil station is looking into it. President Farber thanked Boy Scout Troop #1133 and Scout Leader Randy Ackley for their help cleaning up after the festivities. He thanked the police department and DPW as well for all of their hard work.

Committee Reports:

Buildings, Grounds & Equipment: Herin spoke about the bids that were received for the office reconfiguration. He said that he would abstain from voting due to close relationships with both companies. He said that M. Seng Enterprises did not have a crew and that Smith Builders did.

Parks: Slocum reported that the location of the Kayak Landing Project has changed and has been moved from the island to the old boat launch location just north of the island off of Maple Island Road. Slocum mentioned that Councilperson Walker floated the river last month and the proposed location on the island was difficult to get out off.

Police and Zoning: Chief Herremans reported that there were 47 complaints, 83 traffic contacts, 1 traffic accident and 14 arrests for the month of June. He had 1 zoning request and issued 5 zoning ordinance violations. He reported that Officer Vanderwall has completed the Cops in Court training. He ordered printers and stop sticks for the police vehicles and they will be installed in July. He has scheduled the modem connection to the vehicle to be repaired soon. There were three cases for juvenile court for Hesperia Schools in June.

DPW Report: D.P.W. Director, Mike Stanaway reported on water distribution. Completed 9 Miss Digs. He reported that the 4th of July festivities went well and thanked the police chief for his help. Discharge from the W.W.T.F. has halted for the summer and will resume in September. He has filed the application for the discharge permit. The Consumer Confidence Report was released in June. The electrical issues at the Sewer Lift station and Wells #1 & #2 have been resolved. Installed new 2" meters at 120 and 140 Town Place. There is a pending repair of a service line on Maple Street near State and Maple. Will investigate some addresses with low water pressure. Would like to purchase a new locator.

Discussion: Herin asked about this previously being voted on. Farber explained that the previous vote was to have the village make a one time payment and this Resolution is to amend the budget so the invoice can be paid.
