**Buildings, Grounds & Equipment:** Herin reported that the Bell Tower is complete and work will start soon on the two entrance signs. He spoke to a commercial painter and they said that the building needs to be pressure washed and a mason needs to fill in the cracks prior to painting. He has only received one bid thus far. Herin said that it is difficult to get companies to come to this area. The bid deadline is June 6<sup>th</sup>, 2022.

Finance & Personnel (Legal & Insurance): McDonald said that a meeting was held on April 14, 2022 regarding paying for a CDL license for a DPW employee with a signed agreement. Police Department interviews were held on April 14, 2022. Recommendation is to continue to look to fill the position. Interviews for the DPW position was held on April 29, 2022. More interviews will be held tomorrow.

Pending repairs include finish installing WI FI in parks, road patching, replacing road signs and a water service line replacement. He stated that the repairs have not been made to the restrooms in Weaver Park and will remain closed. A portable toilet has been placed near the restrooms for public use.
