Finance & Personnel (Legal & Insurance): McDonald reported that a meeting was held on January 4, 2024 to review monthly invoices and to discuss changes to Sections 205, 210, 215 and 230 in the employee handbook. It was brought to the committee's attention that there were some minor contradictions regarding which vacation, holiday, sick and personal days could be accrued towards time worked. The proposed changes would make it clear which time would be allowed for hours accrued towards time worked.

Zoning Administrator Report: Micklin reported that he has received some calls regarding inquires from out of town people who are interested in moving to the village,. He said that complaints have dropped off. He has sent some letters out. He said that there had been an arraignment for the house of Cook Street. The pretrial is set for January 17, 2024. Micklin said that the paperwork had been sent in for the house on Winter Street. He would like a court resolution for that residence sometime in February. Micklin gave the annual report for 2023. He said a total of 9 permits were given and approximately \$224,000.00 invested in the village. There were 22 complaints. 84 letters had been sent out and there were 5 citations issued. Two complaints are in the process of going through the courts.
